YEAR IN REVIEW

The 2020-21 year has been another year replete with unique challenges and changes. With the global pandemic still making its mark, schools have reopened and life is gradually getting back to some semblance of normalcy.

Even with the ever-changing landscape of how education and life in general look in the midst of unknowns, SLED has continued to make an impact on our local schools and community with flexibility and focus on new programs, and we continue to find new ways to engage our donors and sponsors. We have highlighted some of these initiatives in the next section of the report.

SLED has seen changes in our organization as well. Last year's annual report introduced Terra Cole Brown as our director, but she has since departed for other opportunities (and an expanding family), and we wish her all the success in her new roles. We now welcome Kate Miller as Executive Director, and she will be continuing on with the strong foundations left by previous leadership, and will carry on building our technology infrastructure, strengthening community and sponsor relationships, and directing SLED's resources as needed to align with our objectives. We will continue to embrace change and look forward to making a greater impact than ever in the year ahead!

SLED IMPACT IN ACTION

One successful program that evolved in the last year is our [Removing Barriers Fund](#). It's clear that one of the roadblocks to a good education is the lack of stable housing and basic necessities. Did you know that there are over 200 foster or unhoused students in SLUSD that need support? Through the Removing Barriers Fund in partnership with the school district, SLED has helped to fund groceries, sanitation kits, school resources, school supplies, and clothes to help these students on their path to success.

A new program SLED piloted in 2020-21 is our [Internship Stipend Program](#). SLED has partnered in the past with SLUSD to assist with internship placements for students to offer invaluable work and professional experience. This past year we expanded that with the help of the Alameda County Office of Education and the Braddock Foundation to provide stipends to unpaid interns in Lincoln High's Farm to Fork program and the unpaid interns participating in the SLHS Internship IOI program. The addition of the paid stipend made it possible for students who may rely upon paid summer work to be able to benefit from unpaid career oriented internships.

Given the expanded remote instructional landscape that the pandemic has created, SLED has also been able to help support the independent study programs in the district. We funded a coordinator position at SLUSD in 2020-21 to help with distance learning. This year we continue to assist funding an [Independent Study Coordinator](#) at SLUSD. This position provides critical outreach to elementary level independent study students, and offers virtual literacy and STEAM-centric activities. With a generous grant from General Motors (with the assist from FH Dailey Chevrolet of San Leandro), more hands-on science kits and supplies will begin to arrive in January to further engage the elementary and middle school independent study students.

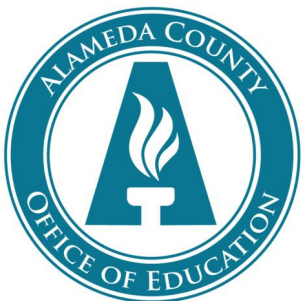

Our ever popular [Teacher Mini-Grant program](#) was streamlined during the last year to make it simpler than ever for teachers in the district to apply to the program to get funding for hands-on, project-based learning. All of these grants are paid for directly by donations from our supporters. You can see one stunning example of a project that SLED funded here - Ms. Tealdi's 5th graders at Washington Elementary School were able to collaborate with local artists Joanna Esparza, Kenny Taitague, and Kimb Taitague to create this incredible mural that represents vital issues like race, identity, and justice and conflicts therein, while projecting hope and optimism.

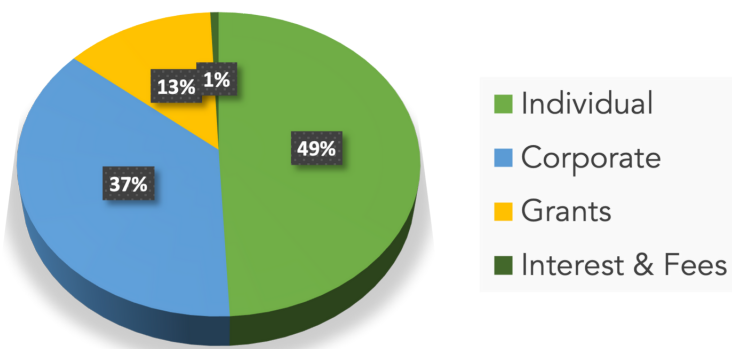

FISCAL REPORT 2020-21

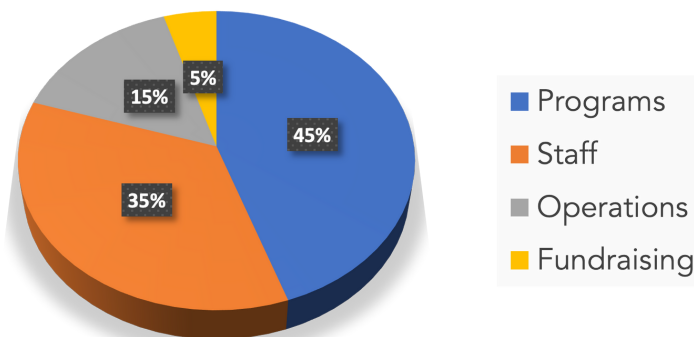
With schools online for the majority of the fiscal year, our program spending adapted to fit the needs of San Leandro students. Despite the changes, SLED was able to fund many exciting projects, like the following:

- Contributed \$50,000 to support staffing for elementary online student engagement, focusing on STEAM and literacy
- Granted over \$45,000 in Teacher Mini-Grants at the elementary and secondary levels
- Successfully piloted paid internship stipends and paid \$3,250 directly to students in intern placements (and \$18,200 in July) - a program with planned expansion in the coming year
- Gave \$5,000 to the Removing Barriers Fund - increasing to \$10,000 for the 2021-22 fiscal year

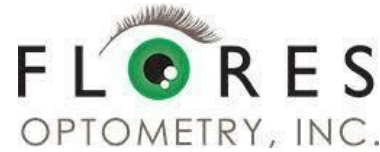
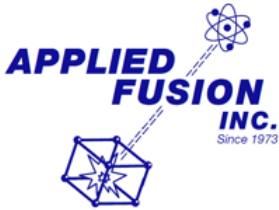
